Care and Maintenance:

I will walk when carrying the iPad.

- I will keep the iPad in its case at all times.
- I will be the only user of the iPad.
- I will store the iPad in accordance with my classroom teacher's instructions.
- I will not use the iPad on school grounds before or after school hours (9am - 3:30pm).
- I will ensure the iPad does not come in contact with any liquid substances.

Loss or Damage to the iPad:

When the iPad is outside of the school's supervision, it is the responsibility of the parent/guardian to ensure reasonable care is taken in the storage and use of the iPad. Once damage or a technical issue is reported to the classroom teacher, the device will be examined by our technician and a course of action decided.

If the damage to the iPad is determined not to have been caused through reasonable use in accordance with the above care and maintenance recommendations, the parent/guardians agree to be liable for the excess of \$125 for repair through the school's nominated repairer.

The iPad is subject to the warranty policy of the supplier. School iPads are not covered for accidental damage or theft. If an iPad is lost, stolen or damaged, parents/ caregivers will be required to contact the iPad coordinator or appropriate classroom teacher and complete the appropriate paperwork for repair.

If an iPad is stolen, parents/ caregivers will be required to obtain a police report.

Teaching staff are to be notified of physical damage or technical based issues as soon as they arise. Any repair from reasonable use will be covered under the iPad manufacturer's warranty, which is standard for all appliances sold within Australia through Consumer Law. If there is a fault that is not from negligence or deliberate damage, it will fall under the manufacturer's warranty.

Parents/ Caregivers are not authorised to organise a third party to complete repairs or repair the device themselves. Parents/ Caregivers will be responsible for the first \$125 of all repairs. Parents/ Caregivers will be responsible for all costs associated with negligent or deliberate damage.

Use Agreement

I have read the above information about use arrangements for the use of the iPad.

I understand and agree with the terms and conditions of the use agreement.

The school will collect all iPads in December for maintenance and will not be available for student use over the summer holidays.

Use Arrangement

A) Coburg North Primary School will allow the student to use the iPad during the agreed period.

B) The parent has read and abides by all the details outlined in the 1:1 policy.

C) Parents/ Caregivers and students are responsible for all content stored on the machine, ensuring it is legal and follows applicable copyright laws for media, music and film.

Agreement Termination

A) This agreement comes to an end:

- At the end of the use period.
- In the event of default as defined in subclause (B) thereof.

B) Default occurs if:

- The student leaves CNPS before the end of the use period
- Consistent inappropriate use at home or school.
- Failure to abide by the 1:1 or internet usage policies.
- Failure to appropriately care for and/or maintain the iPad within guidelines set by the manufacturer and school.

The Device

The parents and the students will operate, maintain and store the device with due care and in compliance with the instructions and recommendations of the supplier and manufacturer of the iPad and pursuant to any directions given by the school. The iPad must be transported to and from school in the case provided.
